RE: Cease and Desist Making False and Defamatory Statements Against Robert E. Murray and Murray Energy Corporation and Publish Retraction of October 17, 2013 Article Titled "Yes, Virginia, There is a Santa Claus – Campaign Cash"

Dear Mr. Moyers:

We are writing on behalf of Murray Energy Corporation and Mr. Robert E. Murray with regard to the absolutely false, defamatory and very damaging statements published by you and Mr. Michael Winship on the website BillMoyers.com on October 17, 2013, in the article titled "Yes, Virginia, There is a Santa Claus – Campaign Cash." (the "Article"). A copy of the Article is attached.

The Article contains false and defamatory statements regarding Murray Energy Corporation and Mr. Murray, including the assertions that:

"What's more, his donor list includes considerable checks from big tobacco and big coal, including Murray Energy Corporation, which has often been fined for endangering the health and safety of its miners. Last year, its boss, Bob Murray, was discovered insisting that employees contribute time and money to his favorite antiregulatory candidates – including Mitt Romney – or else." ("the Defamatory Statements").

The above-mentioned Defamatory Statements have severely harmed the reputation of Murray Energy Corporation and Mr. Murray and have cast Murray Energy Corporation and Mr. Murray in a false light before the public. The Defamatory Statements could also not be further from the truth. Mr. Murray has a reputation for integrity and honesty and has been a leader in October 23, 2013 Cease and Desist Letter Page 2

the coal industry and business community, adhering to an "open door policy" with his employees and working tirelessly to create jobs and preserve the livelihoods of thousands of coal miners, with the health and safety of miners always foremost on his mind. The Article, of course, ignored all of these facts and instead seemed bent only on smearing Mr. Murray's good name and reputation. Indeed, neither Mr. Winship nor you even so much as contacted Mr. Murray prior to publishing the Article either to verify the facts or to give Mr. Murray a chance to present his side of the story. To so irresponsibly publish such one-sided rubbish is shameful and demeaning to your profession.

The Terms of Service of BillMoyers.com, which apply to "all materials ... that is or becomes available on the Site," provide that those posting information on the website "shall abide by all applicable federal, state and local laws, including those pertaining to such areas as libel, slander, defamation, trade libel," and other torts. If the Article is not immediately retracted, we will immediately file litigation against you in order to remedy the reputational harm caused by your publication of the Article.

If you wish to avoid litigation over your actions in defaming Mr. Murray and Murray Energy Corporation, we expect that, no later than one week from today, you will take the following actions:

- 1. Publish and prominently display a statement on BillMoyers.com explicitly retracting the Defamatory Statements;
- 2. Permanently delete the Article, and all links to it, from BillMoyers.com and any other websites under your control;
- 3. Make no further defamatory statements concerning Mr. Murray and Murray Energy Corporation.

If the actions listed above are not taken within one week from today, we will file a lawsuit on behalf of Murray Energy Corporation and Mr. Murray seeking compensatory and punitive damages and attorneys' fees.

Thank you for your immediate attention to this matter.

Strange bedfellows, these crony capitalists - you may remember that Hillary Clinton's brother, Tony Rodham was involved, too, searching out foreign investors for the electric cars. Last year, its boss, Bob Murray, was discovered insisting that employees contribute time and money to his favorite anti-regulatory candidates - including Mitt Romney - or else.

Now Cuccinelli's touting a major tax cut for the rich, with a plan that, according to the liberal Center for American Progress, would give 47 percent of a proposed tax reduction to the top five percent of Virginians. The state would lose nearly a billion and a half dollars in revenues so the rich can be even richer.

Not surprising, Cuccinelli's a major climate change denier, as well as a fractious opponent of Obamacare, a woman's right to choose and gay marriage. He once wanted to make it legal for employers to fire an employee if they were heard speaking Spanish. No wonder he's the favorite of *Citizens United* – yes, that *Citizens United*, the right wing group that got the conservatives on the Supreme Court to give corporations the same free speech rights as real people.

So come Election Day, pity the voters of Virginia. Whether they choose the glad-handing Democrat or the self-righteous Republican, once again, the real winner will be Big Money.
